Just FYI as it impacts budget item. Here is the response I sent to a resident to the screen shots he sent me, attached. He's not convinced and thinks it is an expenditure to support the project. Facebook messenger has a terrible interface and I wish they would just email.

People talk about me all the time on social media so thank you for asking directly. There is no subsidy and no payment to the developer. The 80 is a capital budget line item for infrastructure to bury utility lines, a public improvement. All of our meetings and documents related to budget are public and this is transparency. If people want to believe something untoward is going on they will believe that. We as a city just completed a major planning process including civic campus plan called spaces and places that identifies first Ave around Fairview, school and library as a civic opportunity hub. It's likely we'll do more planning focused in that area. Planning and infrastructure are basic functions of city government and enhancements to both are needed as private ownership turns over and our school improves their adjacent site. If the funeral home project proceeds the overhead lines need to be moved due to their location. The developer has no obligation to bury them when asking utility to move them. We don't have to bury them either. However, it would be a significant aesthetic improvement to our streetscape in an area congruent with our overall planning, so an opportunity if indeed the project proceeds. The city would control the utility project and work with utility directly. I actually just heard the project is proceeding but that has gone back and forth several times. You want to send me your email I can provide the actual text write up we got for this line item.

1. Core Drilling (\$15,000-\$30,000)
2. Underground Conduit (\$5,000-\$10,000)
